



Pest Management Program Overview

Michigan State University is a 501(c) 3 Educational Institution which operates W.K. Kellogg Experimental Forest. The priority is research, outreach, and education in support of the **Land Grant Mission**.

Archery hunting is a popular and important recreational activity in Michigan. Hunters play a significant role in deer management and data collection associated with fluctuations in population size, health and mitigating damage of active research.

Kellogg Forest offers one of the most unique hunting experiences in southwest Michigan with 157 different species of trees growing in various cover types on 720 acres of actively managed working forests.

The pest management program helps MSU by improving the amount and quality of data collected. It will also enable MSU Staff to keep hunters informed about upcoming research, management, or educational events which have priority over other activities. Most importantly, monitoring who accesses the property allows MSU to provide the safest experience possible for all hunters, visitors, and staff.

Hunters will be provided with materials digitally via email which include harvest sheets, maps, and newsletter. Parking permits will be mailed via USPS.

Photos of your harvest are encouraged and will be included in the annual newsletter!

Kellogg Forest hunters will be required to comply with all Michigan DNR rules and requirements, including obtaining and displaying a license and submitting any samples for collection.

Data collected may be shared with Michigan Department of Natural Resources, other educational institutions and state and federal partners to help promote important wildlife management and research.

Hunters may apply for a Kellogg Forest Permit each season from **May 1st through June 15th**. Hunters may apply for the annual permit as an individual or a group of up to four (4) hunters.

Permits are issued on a first-come, first-served basis.

Hunters are required to complete harvest sheets. The harvest sheets must be submitted to the Kellogg Forest Manager at the end of the season.

Pest Management Permit Application Process

Applications must be submitted annually – **Application period is May 1st through June 15th**

Hunting Dates:

- Archery hunting is permitted from **October 1st – January 1st**
- Seasons before October 1st are **NOT** Authorized
- Consideration of season extensions such as ext. late antlerless at sole discretion of MSU

Permit Fee:

- \$55 per hunter (Cash or Check payable to **Michigan State University**)
 - **NON-REFUNDABLE – ALL SALES ARE FINAL**

Requirements:

- Fully completed application in including initialed Pest Management & Tree Stand Policy
- Payment
- Hunters who participated in previous season(s) that failed to submit harvest sheet are not eligible

Submission of Application:

Processing:

- Applications will be processed after **June 15th**
- Hunting packets/permits will be distributed by **August 31st**.
 - Permit, maps, harvest sheets, and newsletter digitally via email to group lead
 - Parking pass via USPS

Use and Restrictions

- 1) The parking pass must be prominently displayed in vehicle while hunting.
- 2) The Permit is for the sole use of hunter(s) named. MSU representatives may ask for permit #, photo ID, and hunting license to verify they are the hunter named on the permit.
- 3) There is a \$50 replacement fee for any lost permit/parking pass.

Pest Management Policy

- **ABSOLUTELY NO FIREARMS** permitted on Michigan State University property.
- Registration is required at map & sign-in/out log at visitor parking lot each hunt
- One** hunter or hunting group per hunting zone only.
- Select one hunting zone from the map. First come, first serve basis. Place marker on zone you will hunt.
- Register location on sign in sheet. **ALL INFORMATION IS REQUIRED TO REGISTER.**
- You must sign-in/out each time you arrive or leave the property.
- When parking, **DO NOT** block gates, roadways, or access drives. Vehicles found to be in violation may be TOWED at owner's expense
- NO HUNTING** in Safety Zones, within 450ft of any building or 150ft of gravel loop or parking lots. (Lemmi Loop)
- NO BAITING** allowed.
- Observation Sheets and any Harvests must be recorded and submitted at end of hunting season.
- All other State Regulations apply.

Tree Stand Policy

- Only temporary portable stands or platforms can be used in the Forest. Stands cannot be affixed or attached to any tree by nails, screws, or bolts.
- Stands and blinds cannot be placed on MSU lands any earlier than **Sept. 1st, and must be removed by March 31st.**
- Stands and blinds left on MSU land outside of these dates will be deemed abandoned and disposed of by MSU.
- Hunter or Group ID **MUST** be prominently displayed on the stand or platform.
- Stands and tree steps cannot cause excessive damage to trees; screw-in steps are **NOT** permitted.
- Stands cannot be placed in walnut trees; it is the responsibility of the hunter to identify tree species.
- Stands must not be visible from the main (gravel) forest road, and cannot be within 450 feet of any building.
- Only a minimum of branches may be removed, using hand pruners, to improve shooting lanes. Branches cannot be cut with saws or loppers or torn by hand.
- Only temporary blinds may be used.

Kellogg Forest is a multiple-use property open to the public during posted hours for certain forms of recreation. You may be briefly interrupted by other visitors passing by on hiking trails. Any hunter harassment by other visitors or dogs off leash should be promptly reported to management or DNR Conservation Officers/Animal Control. Management will do its best to inform hunters of operational activities during business hours. However, you may be inadvertently interrupted by research, management or educational activities which have priority.
